

A New "Chapter"

for Holy Family



Every four years the Sisters of the Holy Family gather in Chapter, the legislative body that is “the most complete expression of collegial authority within SHF” (Constitutions of the Sisters of the Holy Family, #70).

Religious congregations tend to have a jargon of our own, using familiar words sometimes in unusual ways. “Chapter” is one of those words, though if we look at the everyday meaning of the word, it can cast light on our special usage. We probably most often think of chapters as sections of a book: part of the continuity of the narrative, but a break that marks off different times, scenes or characters. Another common usage of the word “chapter” is in the sense of a change, such as a new “chapter” in one’s life being initiated by a change of employment, a new relationship, retirement.

Like the chapters of a book, our Chapters every four years mark off segments of our history that can be looked at as a unit within the continuous story of the congregation. And like a new “chapter” in a person’s life, our Chapter sets the direction for the following four years, possibly calling for changes in response to the movement of the Spirit.

Chapter gatherings in recent decades have shown the changing face of religious life. Within that change, however, we can also find the unchanging call to follow the Spirit. Photographs of earlier Chapters show Sisters in traditional habits seated formally in neat rows. The work of Chapter was done in secret by a small representative group of elected members, while those who were not elected delegates awaited word of what Chapter decided. Recent Chapter gatherings have been open to all vowed members of the congregation as well as to associates, unless an Executive Session (voting members only) or Internal Session (vowed members only) is called. We most often sit at round tables for small group discussion, and frequently voting and non-voting members are mixed in order to enrich our table talk.

While photos can show the marked changes in Chapter from session to session, it is the Acts of Chapter that reveal the continuity. Whether in rows or at round tables, whether in traditional habits or “the modest dress of the women of our day,” at Chapter “the congregation reviews its life, ministry and the founding charism, and it works to be sensitive to the Spirit’s call in the needs of its time. Through the Chapter the congregation governs itself and makes the major decisions necessary to strengthen it for building toward the kingdom [of God]” (Constitutions #73).

Specifically, at Chapter the Leadership Team (the Congregational President and her Council) give a four-year report on how the team and the congregation have lived out the mandates of the previous Chapter and the congregational mission. The Leadership Team also summarizes the finances and other resources of the congregation, with some projections for the future (this year for the first time it was a PowerPoint presentation on

the computer!). Through processes both during and outside of formal Chapter sessions the Chapter members determine the direction for the Congregation for the next four years, and a new Leadership Team is elected to implement those directives.

At past Chapters those deliberations concerned such topics as the Sisters' day home ministry, Holy Family College, the Sisters' habit, the creation of a Finance Advisory Board, the changing needs regarding an intermediate level of leadership, and the nature and purpose of sponsored ministries. Feelings can run high and deep during Chapter, and time is devoted to prayer and to social gatherings to help us keep our focus.

Our current Chapter, begun in June 2006, continued in December 2006 and to be completed in April 2007, is considering the configuration of the congregation, specifically in regard to an intermediate level of leadership to address pastoral needs of the Sisters, and broadly in relation to the larger picture of religious life throughout the United States. All our

deliberations are carried out in the context of how we can most effectively fulfill our mission "to seek out and advocate for the poor and needy, especially families, for the kingdom of God."

In essence, every four years we come together to evaluate our lives and ministries in relation to the congregational mission, the Gospel mandate and the changing needs of the people of our times, and we make whatever changes are necessary to continue our movement toward the kingdom of God. Chapter is a valuable institution in helping us stay on target as a religious congregation. Perhaps a similar periodic review could help families and even individuals to stay focused!




